## Interparfums joins the SBF 120 and CAC Mid 60

Following its latest quarterly review, the Scientific Council of Euronext Paris has decided to include Interparfums' share in the SBF 120 and CAC Mid 60 indices effective March 21, 2022.

The SBF 120 is a major index of the Paris Stock Exchange consisting of the 120 largest companies listed on Euronext Paris based on the free float and liquidity of their shares.

As a reminder, Interparfums is listed on compartment A<sup>(1)</sup> and has been eligible for the Deferred Settlement Service (SRD)<sup>(2)</sup> on Euronext Paris since 2018.

(1) Market capitalization of more than €1 billion.

(2) A mechanism giving investors on Euronext Paris the ability to defer the settlement or delivery of their securities until the end of the month.
